ORDER

(Order of the Court was made by A.D.JAGADISH CHANDIRA,J.)

The present Writ Petition is filed by the wife of the convict prisoner for a writ of mandamus seeking to direct the respondents to effect the premature release of the petitioner's husband namely T.Babu, S/o.Thangappan (Convict No.LCVT 8442), aged about 64 years.

2. When the matter is taken up for hearing today, the learned Additional Public Prosecutor appearing for the respondents would submit that petitioner's representation, dated 02.03.2024 has been received by the

respondent and in that representation, a wrong Government Order has been quoted, however, the Officials shall ensure that the applicable Government Orders will be taken into consideration and the representation of the petitioner will be considered within a period of twelve (12) weeks.

3. Recording the submission of the learned Additional Public Prosecutor, without going into the merits of the matter, we direct the respondents to consider the representation of the petitioner, dated 02.03.2024 and pass orders on merits and in accordance with law within a period of twelve (12) weeks from the date of receipt of a copy of this order.

4. Accordingly, this writ petition is disposed of. No costs.
