Prayer in WP(MD). 6682/ 2024 :

Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, to call for the impugned proceedings in Na.Ka. No.93/Minerals/2024 dated 11.03.2024 on the file of the 1st respondent, to quash the same as illegal, arbitrary and without jurisdiction in so far as it relates to item No.6, Bodinayakanur Taluk, Kodangipatti Village Government Poromboke land in S.F. No.32/2 (Part 4) 2.50.0 hectares stone quarry and further direct the respondents to receive the balance bid amount of Rs.4,50,00,000/- (Rupees Four Crores and Fifty Lakhs) and execute the mining lease.
