3.The learned counsel appearing for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. Hence, he prays for grant of anticipatory bail to the petitioner.

4.The learned Government Advocate (Crl.Side) appearing for the respondent Police submits that the petitioner is having four previous cases, out of which, one case is similar in nature.

5. Considering the antecedent of the petitioner and also considering the nature of allegation, this Court is not inclined to grant any relief to the petitioner. Accordingly, this Criminal Original Petition is dismissed.
