Today, when the matter was taken up for hearing, the learned counsel appearing for the petitioners submitted that the matter has already been settled between the parties before the Mediation and Conciliation Centre attached to this Court on 16.04.2024 and the terms of agreement for settlement was also signed by both the parties and prays for allowing this petition.

3. Heard the learned counsel appearing for the petitioner, the learned Additional Public Prosecutor appearing for the first respondent and the learned counsel for the 2nd respondent.

4. Since the matter has already been settled between the parties before the Mediation Centre and the terms of agreement for
