This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant Mr.G.Prabhu Rajadurai and the counsel for the respondents Mr.M.Subramanian are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

The tribunal has awarded a sum of Rs.15,79,308/- with 7.5% interest. Challenging the said award, this civil miscellaneous appeal has been filed.

2. Both parties are present and arrived at a one time settlement for a sum of Rs. 11,50,000/- as full quit. The appellant is directed to deposit a said amount within a period of four months from today less the amount already deposited before the tribunal. The respondents 1 & 2 are entitled to withdraw a sum of Rs.5,75,000/- each without filing proper application before the court below.
