2.At this juncture, the learned Additional Public Prosecutor appearing for the State would submit that in the said summon, the petitioner was directed to appear before the first respondent on 01.10.2020 at 05.00 p.m., and the date has passed on. Therefore, contended that the present criminal original petition becomes infructuous.

3.At this juncture, when the matter was listed before this Court on 06.03.2024, this Court has ordered as follows:
