2. It is now brought to our notice that there were peace committee meetings held and ultimately, the Vaigasi festival was also held in the third week of June 2024. As such, the cause of action that persisted in the writ

petition has become infructuous, in view of the conduct of the festival and hence, no effective orders can be passed in this writ appeal.
