ORDER

The instant writ petition has been filed by a B.T. Assistant (Science) Teacher, who was appointed by the fifth respondent School Management, seeking to quash the order passed by the fourth respondent herein, wherein the proposals submitted by the School Management for approval of her appointment has been returned.

2.A perusal of the impugned order reveals that the fourth respondent has referred the interim order passed in W.A.(MD)Nos.76, 225, 241 of 2019, 1612, 1074, 1093, 1461, 1773 and 1531 of 2018 and has returned the said proposal without assigning any further reasons. 1612, 1074, 1093, 1461, 1773 and 1531 of 2018 had already been disposed of and SLP, filed as against the order of the Hon'ble Division Bench, has also been disposed of. On such submission, the third and fourth respondent herein are directed to consider the said proposals and pass orders on merits in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.

3. With the above said observations, this writ petition stands disposed of. No costs. Consequently, connected miscellaneous petition is also closed.
