3.Considering the submission made by both sides, the condition imposed on the petitioner in paragraph No.6(c) in Crl.O.P.(MD).No.7519 of 2024, dated 22.05.2024, “6(c) the petitioner shall deposit a sum of Rs.1,50,000/- (Rupees One Lakh and Fifty Thousand Only) to the credit of Crime No.11 of 2024, before the concerned Magistrate, at the time of executing bond”, is modified to the effect that “ the petitioner shall deposit a sum of Rs.10,000/- (Rupees Ten Thousand Only) to the credit of Crime No.11 of 2024, before the concerned Magistrate, at the time of executing bond”. The other conditions passed in the order dated 22.05.2024, made in Crl.O.P.(MD).No.7519 of 2024, remain unaltered.

4.The Criminal Original Petition is ordered accordingly.
