The present petition has been filed by the appellant/sole accused to suspend the sentence imposed on him by the learned Special Court for Exclusive Trial of Cases under POCSO Act, Virudhunagar District at Srivilliputhur in Spl.S.C.No.37 of 2016, dated 08.10.2021.

2. It is seen from the records that this is the fifth application for suspension of sentence. The earlier application filed by the petitioner in Crl.M.P(MD)No.1800 of 2022 has been dismissed on merits holding that it is not a fit case for grant of suspension of sentence. Earlier, this Court directed the Registry to post the main
