2. The learned counsel for the petitioner submitted that now the petitioner is residing at Madurai along with her age old parents and her twin children aged about 4 years. He further submitted that and she has to take care of her children and old aged parents and she has to travel around 220 kms to attend the Court proceedings from Madurai to Coimbatore and also to bear the travel expenses for each and every hearing and hence, it is very difficult for her to contest the case before the II-Additional Sub Court, Coimbatore, Coimbatore District. Considering the pendency of the case, this Court withdraws H.M.O.P.No.425 of 2022 from the file of the II-Additional Sub Court, Coimbatore, Coimbatore District and transfers the same to the Family Court, Madurai. The II-Additional Sub Court, Coimbatore, Coimbatore District, is directed to transfer the entire records in H.M.O.P.No.425 of

2022 to the transferee Court forthwith. The transferee Court shall receive the records and assign a new number, send notice to both parties and proceed further in the matter.
