Prayer : Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Mandamus, to direct the respondents no.4 and 5 to conduct survey and fix boundary in Survey No. 648 (Government Poramboke Land), Edirkottai Village, Vembakottai Taluk, Virudhunagar District and consequently direct the respondents no.1 to 5 to provide necessary protection for conducting quarry of rough stone by considering the Petitioners representation dated 10.05.2024 within a stipulated time that may be fixed by this Court.

ORDER

The grievance of the petitioner is that in the said site, some quarry had already taken place. All that the petitioner wants is that proper survey should be conducted and the boundary stones should be fixed. He also wants an inspection to be done to quantify and measure the
