2.The case of the prosecution is that there was a wordy quarrel between the petitioners and the defacto complainant, in which, the petitioners abused the defacto complainant in filthy language and also attacked the defacto complainant and his wife with iron rod and caused injuries.

3.The learned counsel appearing for the petitioners submits that the petitioners are innocents persons and they did not commit any offence as alleged by the prosecution.

4.The learned Government Advocate(Crl.side) appearing for the respondent Police opposes to grant anticipatory bail to the petitioners on the ground that the injured person is still taking treatment in the hospital.

5.Considering the facts and circumstances of the case and considering that the injured person is still taking treatment in the hospital, this Court is not inclined to grant anticipatory bail to the petitioners. Accordingly, this criminal original petition is dismissed.
