3.The learned counsel for the petitioner submits that the petitioner is an innocent person and he has not committed any offence as alleged by the prosecution. However, he is languishing in jail from 21.06.2024.

4.The learned Additional Public Prosecutor appearing for the respondent submits that the petitioner already filed a similar petition in for bail before the Court below and the same is pending.

5.Considering the submission of the learned Additional Public Prosecutor, this criminal original petition is dismissed with liberty to the petitioner to workout his remedy before the Court below.
