The learned Counsel for the petitioner/defacto complainant submits that earlier this Court in CrI.O.P(MD)No.6051 of 2024, has granted anticipatory bail to the accused by considering the nature of allegation and the enquiry was pending, on the file of the respondent police. However, during the course of enquiry, the petitioner was not provided an opportunity to submit his allegations.

2.It appears that till now, the respondent police has not registered a case as against the accused. Since there is no apprehension of arrest, there is no necessity for anticipatory bail and cancellation of anticipatory bail.

3.Accordingly, this petition is dismissed.
