Court, Sattur and transfer the same to the file of the Sub Court, Kovilpatti, Thoothukudi District.

2. The petitioner is the wife and the respondent is the husband. The marriage between the petitioner and the respondent was solemnized on 20.08.2015 at Idumban Kovil, Shasti Viratha Mandapam, Tiruchendur, Thoothukudi District as per the Hindu Rites and Customs. Out of the wedlock, a female child, named Mahathi Sri, was born on 29.05.2016.

3. Due to disputes and differences, the parties have separated, and the petitioner/wife has initiated the proceeding in M.C.No.10 of 2022 on the file of the Judicial Magistrate No.I, Kovilpatti seeking maintenance. Thereafter, the respondent/husband has initiated the proceeding in H.M.O.P.No.71 of 2024 on the file of the Sub Court, Sattur seeking divorce.

4. The name of the respondent has been printed in the cause list. Despite the name has been printed in the cause list, the respondent/husband has neither entered appearance through a counsel nor in-person to oppose this transfer petition.

The learned Judge, Sub Court, Sattur is directed to transmit the entire records, pertaining to the case in H.M.O.P.No.71 of 2024 to the file of the Sub Court, Kovilpatti within a period of three weeks from the date of receipt of a copy of this order, and on receipt of such records, the learned Judge, Sub Court, Kovilpatti, Thoothukudi District is directed to take the case on file and dispose of the same as expeditiously as possible in accordance with law.

10. Accordingly, this Transfer Civil Miscellaneous Petition stands allowed. No costs. Consequently, the connected Civil Miscellaneous Petition is closed.
