4. The petitioner is said to have been working in Educational Department as part time Sweeper for the past 10 years. After 10 years of service, his service has not been regularised so far. Hence, the petitioner has filed this writ petition seeking a direction to the respondents to regularise the services.

5. The learned counsel for the petitioner submitted that the petitioner is entitled to get the benefit as per G.O.(Ms)No.22 Personnel Administrative Reforms Department, dated 28.02.2006.

6. However, learned Additional Government Pleader appearing for the respondents submitted that the above Government Order is not applicable to the case of the petitioner.
