PRAYER :-

2.The case of the prosecution is that the petitioner, by posting himself as an Auditor, undertook to file income tax returns of many of the traders in Aruppukottai Town and also he got his fee from them. However, he failed to file the returns, resulting loss/fine to the traders. Hence, the complaint.

3.The learned Additional Public Prosecutor appearing for the respondent would submit that after registering this case, four other victims have given complaint before the Commissioner of Police.

4.Heard the learned counsel on either side and perused the material records of the case.

5.Considering the facts and circumstances of the case, I am of the view that this is not a fit case to grant anticipatory bail. Accordingly, this criminal original petition is dismissed.
