This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant Mr.C.Karthik and the counsel for the respondents 1 to 3 Mr.R.Muruganandam are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

Both the parties along with their respective counsels are present. The appellant/Insurance company is agreed to deposit a sum of Rs.68,40,000/- and he seeks time to deposit the same.

2.The third respondent is aged about 80 years and gave power to her grand daughter namely the first respondent. The claimants/respondents 1 to 3 have agreed to receive a sum of Rs.68,40,000/- with interest and cost as awarded by the Court below.

3.Considering the same, the Insurance company is directed to deposit the amount of Rs.68,40,000/- with interest and cost, less the amount already deposited if any, within a period of eight weeks from the date of receipt of the award.

4.On such deposit being made, the third respondent permitted to withdraw the amount of Rs.7,00,000/-. The respondents 1 and 2 are permitted to withdraw the amount of Rs.30,70,000/- each by filing necessary application before the Tribunal.
