This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellant/s Mr.V.Sasikumar and the counsel for the respondents 2 and 3 Mr.V.J.Kumaravel are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

The Tribunal has awarded Rs.6,12,170/- with 7.5% interest against which the claimant has preferred this appeal.

2.Both sides present. As per the settlement arrived in the Lok Adalat, both parties have agreed to settle for a sum of Rs.55,000/- (Rupees Fifty Five Thousand Only) with interest at the rate of 7.5% p.a from the date of petition till realization over and above the amount awarded by the Tribunal. The respondents 2 and 3/ Insurance company is directed to deposit the award amount of Rs.55,000/- with interest within a period of six weeks. On such deposit being made, the appellant /claimant is permitted to withdraw the same.
