Prayer in Crl M.P.(MD)No.8822/2024:-

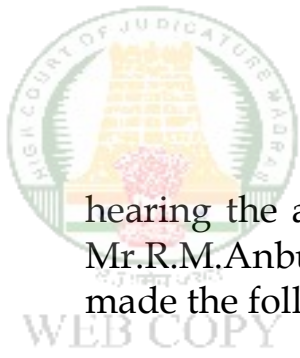
