PRAYER :- For Bail in Crime No.5 of 2024 on the file of the respondent police

ORDER : The Court made the following order :-

The petitioner/ A3, who was arrested and remanded to the judicial custody on 06.05.2024 for the offences under Sections 376(DA) and 376(AB) of IPC and 67(B) IT Act and 11(2), 11(4) r/w 12 and Section 5(1), 5(g) r/w 6 of POCSO Act, 2019 in Crime No.5 of 2024 on the file of the respondent police, seeks bail.

2.The case of the prosecution is that the petitioner made a video call to the

victim and lured her to speak in a nude state. Hence, the complaint.

3.The learned counsel appearing for the petitioner would submit that the petitioner is an innocent and he has not committed any offence as alleged by the prosecution. Hence, he prays for bail to the petitioner.

4. The learned Additional Public Prosecutor appearing for the respondent police would submit that the other accused persons threatened the victim girl and committed penetrative sexual assault upon her on three occasions. On one occasion, the accused video graphed it. When the marriage was fixed for the victim, the accused made the video viral. The petitioner is A3 and he made a video call to the victim and lured her to speak in a nude state. Hence, he has strongly opposed to grant bail to the petitioner.

5. Considering the facts and circumstances of the case and also considering the gravity of the offence, this Court is not inclined to grant bail to the petitioner. Hence, this Criminal Original Petition is dismissed.
