The petitioner therefore seeks sub division and issuance of separate patta.

3.The petitioner is permitted to make another application before the third respondent and remit necessary charges. The third respondent shall entertain the application and pass final order on merits and in accordance with law after issuing notice to the other co-pattadhars. This exercise shall be completed by the third respondent within a period of six months from the date of receipt of a copy of this order.
