2. Though this writ petition is pending from the year 2017, there is no representation on behalf of the petitioner.

3. The learned Additional Government Pleader appearing on behalf of the Official respondents, based on the written instructions, which have been received from the Village Administrative Officer, Rajakambeeram, Sivagangai District, submits that as of now, there is no stagnation of sewage water in front of the petitioner's house.

4. This Court is not satisfied with the report submitted on behalf of the respondents. It is the duty of the Panchayat to maintain civic
