PRAYER :-

For Bail in Crime No.185 of 2024 on the file of the Respondent Police.

ORDER : The Court made the following order :-

The petitioners/ Accused, who was arrested and remanded to judicial custody on 02.06.2024 for the offences punishable under Sections 294(b), 307, 341 and 506(2) IPC, in crime No.185 of 2024 on the file of the respondent police, seek bail.

2.The case of the prosecution is that due to wordy quarrel, the petitioners herein and other accused have attacked the defacto complainant with sword. Hence, the complaint.

3.The learned counsel for the petitioner would submit that the petitioners are innocent and he has not committed any offence as alleged by the prosecution and their names have been falsely implicated in this case. He would further submit that the petitioners are in judicial custody from 03.06.2024, hence, they may be granted bail.

4.The learned Additional Public Prosecutor would submit that there was a wordy quarrel between the parties and now, the injured was discharged from the hospital and the co-accused already released on bail. He would further submit the petitioners herein are having one previous case.

5. Considering the facts and circumstances of the case and also considering the fact that the injured was discharged from the hospital and that the co-accused already released on bail, this Court is inclined to grant bail to the petitioners on certain conditions.

6. Accordingly, this Criminal Original Petition is allowed and the petitioners are ordered to be released on bail, on executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties each for a like sum to the satisfaction of the learned Judicial Magistrate No.III, Dindigul and on further condition that;

(i) the sureties shall affix their photographs and left thumb impression in the surety bond and the Magistrate/concerned court may obtain a copy of their Aadhar card or Bank Pass Book to ensure their identity;

(ii) the petitioners shall report before the respondent police daily at 10.30 a.m., until further orders;

(iii)the petitioners shall not tamper with evidence or witness;

(iv)the petitioners shall not abscond during trial.

v)On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560].

vi)If the accused thereafter absconds, a fresh FIR can be registered under Section 229A IPC.
