2. The petitioner School, which has appointed one T.Vinos Selvakumar as Office Assistant in a vacancy that arose due to the retirement of the then incumbent S.William Packiyanathan, had submitted a proposal to the fourth respondent on 15.02.2023 together with the required particulars and documents for approval of appointment. Since no order was passed on the said proposal, the present writ petition has been filed.
