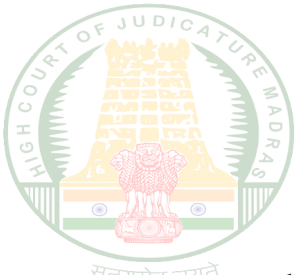
18.03.2025, and through the Principal District Judge, Ramanathapuram,

"The learned District Munsif cum Judicial Magistrate, Kadaladi(FAC) by his letter dated 18.03.2025 has sought further time to dispose of the case in C.C.No.177 of 2019.

This Court had already directed the learned District Munsif cum Judicial Magistrate, Kadaladi(FAC) to dispose of the case in C.C.No.177 of 2019 within a period of three months from the date of receipt of the order. The learned District Munsif cum Judicial Magistrate, Kadaladi(FAC) in his letter stated that the order copy was received by the Court on 17.12.2024 and the case is pending for trial, because of non availability of counsel for the accused.
