3.The learned counsel appearing for the petitioner would submit that the petitioner is innocent and he has not committed any offence as alleged by the prosecution and he is in judicial custody from 02.04.2024 and seeks bail.

4.The learned Additional Public Prosecutor appearing for the respondent would submit that the petitioner herein is prime accused and the A2 is paramour and the charge sheet has been filed in this case and he strongly opposed to grant bail to the petitioner.

5.Considering the facts and circumstances of the case and also considering serious nature of allegations made against the petitioner, this Court is not inclined to grant bail to the petitioner.

6.Accordingly, this Criminal Original Petition is dismissed.
