ORDER

The present Criminal Revision Case has been filed seeking order to set aside the judgment in C.A.No.28 of 2018 dated 24.08.2021 passed by the learned I Additional Sessions Judge, Tirunelveli, confirming the conviction and sentence imposed by the District Munsif cum Judicial Magistrate, Cheranmahadevi in S.T.C.No.639 of 2015 vide order dated 05.01.2018 and consequently, acquit the petitioner from the aforesaid case.

2. It is seen from the records that this revision was taken at National Lok Adalat and the parties have entered into a compromise and on that basis, a Lok Adalat award came to be passed on 14.12.2024.

3. In view of the settlement between the parties and consequent passing of the award, the judgment of conviction passed by the Courts below are hereby set aside and the accused is acquitted from the charges.
