ORDER

When the matter is taken up for hearing today, the learned counsel appearing for the petitioner would submit that since the petitioner was in jail along with one Ramesh, after his release the third respondent as well as the police from Ariyalur has come to the house of the petitioner and they have recovered 3 sovereigns of gold jewels, as if, the same was stolen by the accused Ramesh.

4. The learned Government Advocate (Criminal Side) appearing for the respondents would submit that FIR came to be registered in Crime No.138 of 2024 for the offence under Section 380 IPC against the said
