Prayer in CRL OP(MD).No.9166 of 2024 :

Criminal Original Petition filed under Section 482 of the Code of Criminal Procedure, to permit the petitioners to surrender and accept the bail application filed by the petitioners before the Special Court for SC & ST (POA) Act, Dindigul in connection with Crime No.344 of 2024 on the file of the second respondent Police and in the event of filing the same, the said application may be directed to be considered on the same day on merits and in accordance with law forthwith.

2. The learned counsel appearing for the petitioners would submit that the petitioners could not surrender before the learned Judge concerned and produce the sureties within the stipulated time as prescribed by this Court.
