PRAYER : Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of Mandamus, directing the respondents to (i) strictly and explicitly display the revised structure of the 'Fare Table', Time – Table, based on the classification of 'Stage Carriages' by following the terms and conditions of its permit and by strictly adhering the Motor Vehicles Act, 1988 and the Tamil Nadu Motor Vehicles Rules, 1989 and consequently initiate penal action against the illegalities and violation of the

stage carriage operators and erring officials and (ii) to operate the 'Ordinary Service' stage carriages, with a different body color from that of the 'Express Service' for an easy identification of service.
