2.The petitioner was absent during the trial in C.C.No.44 of 2024 on the file of the learned Judicial Magistrate No.1, Kumbakonam. Therefore, Non-Bailable Warrant came to be issued on 29.07.2024.

3.Heard the learned counsel on either side and perused the material records of the case.

4.It is seen that the petitioner is facing a case in C.C.No.44 of 2024 on the file of the learned Judicial Magistrate No.1, Kumbakonam and on account of her non appearance, Non-Bailable Warrant has been issued. That being the position, the petitioner has to file an application for recalling the warrant and the present petition is therefore closed, however, with liberty to the petitioner to file a recall petition before the concerned Court.
