3. Considering the reasons stated by the learned Judge, further extension of six months time is granted finally to comply with the earlier order of this Court.

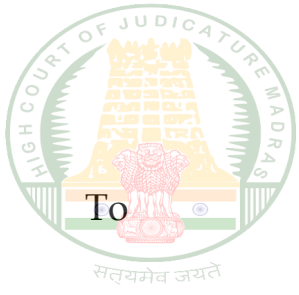
