2.The contention of the petitioners is that based on the complaint lodged by the 2nd respondent, the 1st respondent registered the First Information Report in Crime No.296 of 2016 for the offences punishable under Sections 294(b), 387, 506(ii) IPC r/w. Section 3(1) of TNPPDL Act, against the petitioners and thereafter, the case has been charge sheeted in S.C.No.226 of 2018 on the file of the Additional District Judge, Padamanabhapuram.

3.The further contention of the petitioners is that they compromised the issue with the 2nd respondent amicably. A joint memo of compromise was filed, which has been duly signed by the petitioners and the 2nd respondent and also by their respective counsels.
