Prayer in Crl.MP(MD) No.12641 of 2023:-

The Criminal Miscellaneous Petition filed U/s. 439 (1)(b) r/w 482 of Criminal Procedure Code to extend the time imposed in Crl.RC(MD) No.388/2020 dated 14.07.2020 and permit the petitioner to surrender and execute sureties before the learned Principal District and Sessions Court, Nagercoil.
