This case came up for settlement before the Lok Adalat. Both the parties present. The counsel for the appellants M/s.A.Elis Chitra Devi and the counsel for the 2nd respondent Mr.C.Jawahar Ravindran, Mr.G.Prabhu Rajadurai for 3rd respondent and Mr.B.Christopher for 4th respondent are present. After mutual discussion, negotiation, mediation and conciliation between both parties and with the assistance of the Bench, both sides consented for settlement.

AWARD

The Tribunal has awarded Rs.1,31,300/- with 7.5% interest against which the claimant has preferred this appeal.

2.Both sides present. As per the settlement arrived in the Lok Adalat, both parties have agreed to settle for a sum of Rs.1,20,000/- (Rupees One Lakh Twenty Thousand Only) as full quit over and above the amount granted by the Tribunal. The 3rd respondent / Insurance company is directed to deposit the award amount of Rs.1,20,000/- within a period of four weeks. On such deposit being made, the appellant/claimant is permitted to withdraw the same.
