It is the grievance of the petitioner that he has made a representation dated 13.06.2023 to the first respondent requesting him to cancel the wrong classification of the land, measuring an extent of 2 acres and 5 cents comprised in S.No.300/2, at Karuthapuliyampatti Village, Melur Taluk, Madurai, and to record his ownership on the aforesaid land.
