Under a Lok Adalat settlement decree dated 11.08.2014, in O.S.No.215 of 2008 on the file of the Sub-Court, Madurai, the lands comprised in S.No.68/12 - 1930½ sq. feet; S.No.17/4 - 8¾ cents; and S.No.67/11 - 7½ cents in Anaiyur Bit - II Village, Madurai North Taluk, Madurai District were allotted to the petitioner. The petitioner has made an online application to the respondent for grant of patta on 18.06.2024. However, the respondent has not processed the same and a representation was given to the appellate authority viz., the Revenue Divisional Officer, Madurai, which was also forwarded to the respondent.
