3. Considering the reasons stated by the Court below for extension of time, six months time is extended from the date of receipt of a copy of this order to comply with the order dated 24.10.2024.

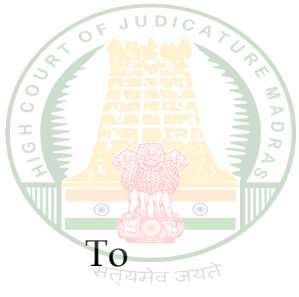
