2. Heard both sides.

3. The petitioner seeks modification apprehending that the respondent may



further put up case against him. When the station proceedings are being recorded in the CCTV, such apprehensions need not be there and the same can always be taken care of by this Court, if there is any excess.

4. Therefore, I am not inclined to modify the order. The petitioner shall comply with the condition originally imposed for a period of three weeks from the date of receipt of the copy of the order and thereafter, the condition shall stand relaxed.
