ORDER

The petitioner is the detenu, namely, Rameshkumar, Son of Ramasubbaiah, aged about 24 years. The detenu has been detained by the second respondent by his proceedings in M.H.S.Confdl.No.51/2024 dated 26.06.2024 holding him to be a "Goonda", as contemplated under Section 2(f) of Tamil Nadu Act 14 of 1982. The said order is under challenge in this Habeas Corpus Petition.

2. The learned Additional Public Prosecutor appearing for the respondents, by producing a copy of G.O.Rt.No.5350, Home, Prohibition & Excise (XIV) Department, dated 05.08.2024, would state that the impugned detention order has been revoked and hence, the prayer sought for in this Habeas Corpus Petition has become infructuous.
