Thereafter, he called for certificate verification by TNPSC, during verification, he was rejected on the ground that B.Com(Professional Accounting) degree is not equivalent to a regular B.Com degree. In this regard, he has given a representation to the first respondent. But the said representation was not considered so far. Hence this writ petition.

4. Considering the facts and circumstances of the case, the first respondent is directed to consider the representation of the petitioner dated 01.07.2024 and pass appropriate orders on merits and in accordance with law as expeditiously as possible.

5. With the above direction, this writ petition is disposed of. No Costs.
