ORDER

4.Considering the above, the respondents 2 to 4 are directed to consider the representation of the petitioner dated 11.07.2024 and pass orders, immediately, by imposing condition for payment of necessary charges for Police protection, in terms of the relevant Government Order.

5.With the above directions, the Writ Petition stands disposed of.
