ORDER

A mandamus is sought for to issue direction to the respondents 1 and 2 to issue patta in respect of the Government Waste Land in which the petitioner has been in occupation for several decades.

2. It is the contention of the petitioner that he is living in the said property. He belongs to the marginalised section of the society and has been living in the property by putting up a house. However, he has not been granted patta and therefore, he had made a representation to the respondents to consider the same and issue him with a patta.

3. The learned Additional Government Pleader would submit that the lands are classified as waterbody and patta cannot be granted.

4. Considering the fact that the petitioner has been permitted to reside in the said property by putting up construction, a direction is

issued to the respondents to consider the representation of the petitioner, dated 09.08.2024 and pass orders on merits by following due process of law, after affording an opportunity of personal hearing to the petitioner. The said exercise shall be completed before 20.09.2024.

5. With the above direction, this Writ Petition stands allowed. No costs.

6. Post the matter 'for reporting compliance' on 20.09.2024.
