When the matter is taken up for hearing today, the learned Government Advocate (Criminal Side) appearing for the respondents would submit that on the basis of the complaint given by the petitioner, FIR came to be registered in Crime No.14 of 2024 on 18.01.2024 for the alleged offence under Sections 406, 420, 465, 468, 34, 294(b) and 506(i) IPC, they have also examined nine witnesses and they are awaiting for bank statements and seeks four weeks time to file final report before the jurisdictional Magistrate Court.
