Writ Petition filed under Article 226 of the Constitution of India, praying this Court to issue a Writ of Certiorarified Mandamus, calling for the records relating to the impugned ex-parte award dated 30.08.2023 passed in Permanent Lok Adalat Case No.11 of 2023, on the file of Permanent Lok Adalat, Tiruchirappalli and quash the same and consequently direct the Permanent Lok Adalat, Tiruchirappalli to proceed with the case in accordance with the provisions of the Legal Services Authorities Act, 1987 and pass such further or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case and thus render justice.

Prayer in WP(MD). 20412/ 2024 :
