4.Considering the nature of allegations that the petitioner being an employee, misappropriated the amount to the tune of Rs.1,14,00,000/- and also considering the facts that the investigation is in the nascent stage and the amount yet to be recovered, I am not inclined to enlarge the petitioner on bail.

5.Accordingly, this Criminal Original Petition is dismissed.
