ORDER

The Criminal Original Petition has been filed, invoking Section 528 B.N.S.S., seeking orders to quash the charge sheet in C.C.No.243 of 2024 pending on the file of the Judicial Magistrate No.IV, Thoothukudi.

2. The case of the prosecution is that there existed matrimonial dispute between the first petitioner and the second respondent and that the petitioners had demanded additional dowry from the second respondent and threatened her.

3. The learned counsel appearing for the petitioners would submit that the second respondent has lodged a complaint before the first respondent and on that basis, FIR came to be registered in Crime No.9 of 2023 and after investigation and filing of the final report, the same was taken cognizance in C.C.No.243 of 2024 for the offences under Sections 498(A), 406 and 506(2) IPC and Section 4 of Dowry Prohibition Act against the petitioners and is pending on the file of the Judicial Magistrate No.IV, Thoothukudi.

4. The case is under trial. By passage of time, the parties have decided to bury their hatchet and compromise the dispute amicably among themselves.

5. A Joint Memo of Compromise dated 07.08.2024 has been filed before this Court which have been signed by the petitioners and the second respondent and also by their respective counsels. The petitioners and the second respondent are present before this Court and and they were identified by M/s.M.Anusuya, Sub Inspector of Police, All Women Police Station, Thoothukudi as well as by the learned counsels appearing for the parties. This Court also enquired both the parties and was satisfied that the parties have come to an amicable settlement between themselves.

6. In the instant case, it is a matrimonial dispute and the parties had compromised. Where the parties have compromised the matter, the High Court has to power to quash the complaint for the offence under Sections 498(A), 406 and 506(2) IPC and Section 4 of Dowry Prohibition Act.

7. The legal position expressed by the Hon'ble Apex Court in the case of ***Gian Singh vs. State of Panjab and another*** reported in ***(2012)10 SCC 303*** and ***Parbathbhai Aahir @ Parbathbhai Vs. State of Gujraath*** reported in ***(2017)9 SCC 641*** were taken into consideration.

8. In the light of the guidelines issued in the above said Judgments of the Hon'ble Apex Court, no useful purpose will be served in keeping the proceedings in C.C.No.243 of 2024 as against the petitioners pending before the Judicial Magistrate No.IV, Thoothukudi, even though, the offences involved are not compoundable in nature.

9. Accordingly, this Criminal Original Petition is allowed and the proceedings in C.C.No.243 of 2024, on the file of the Judicial Magistrate No.IV, Thoothukudi is quashed as against the petitioners and the joint compromise memo dated 07.08.2024 shall form part and parcel of this order.
