ORDER

(Order of the Court was made by M.S.Ramesh J.)

The petitioner, who is a third party to the writ proceedings, had filed the present application for permission of this Court to accept the cause title.

2. It is brought to our notice that at the time of numbering this application, he had made an endorsement in Page No.9 of the typed set of papers that he is not pressing the present application. However, the Registry by inadvertence had numbered the application as CMP(MD) No.15017/2024 and had listed before the earlier Coordinate Bench of this Court. Since it was not brought to the notice of this Court about the endorsement made by the petitioner herein, the Miscellaneous Petition came to be ordered as prayed for on 28.10.2024.
